## Catholic School Subsidy Qualifications 2022/2023 School Year

St. John the Evangelist Parish pays a subsidy to local area Catholic Elementary Schools in order for parish families to receive a lower subsidized tuition rate. This subsidy is only available for Joseph School and Our Lady of Lourdes School for grades K through 8. The subsidy is not available for Pre-K or high school and is not available for other schools. The **Statement of Active Parishioner** form must be completed *each year* for those requesting a parish subsidy.

To determine each family's qualifications for the subsidy, the following documentation of Active Parishioner Commitment must be fully completed and ***returned to the St John the Evangelist Parish Office NO LATER THAN MARCH 15, 2022.***

**The following criteria are required for a family to qualify for the subsidy:**

- Spiritual Commitment**
- Stewardship – Treasure**
- Sign the Statement of Active Parishioner**

**Participation in each of these areas is mandatory. The Pastor will have discretion and the final say in the determination of Active Parishioner.**

## **Spiritual Commitment:**

Families are considered Active Parishioners when they commit to the following expectations of a practicing Catholic:

- The family is registered at St. John the Evangelist Parish
- The family attends regular Sunday Mass and other liturgical celebrations as indicated by the return of the Stewardship envelope in the weekly collection basket at Mass.
- Child(ren) in the family participate(s) in Sacramental preparation and celebrations (i.e. First Reconciliation and first Eucharist), attend other programs offered by the Parish Faith Formation, and receive the sacraments of Eucharist and Reconciliation regularly throughout the year.
- Catholic parents participate in the sacraments on a regular basis.
- Parents and child/ren have an active prayer life.

## **Stewardship – Treasure:**

Stewardship of Treasure is based on a fair and proportionate share of one's treasures and provides the financial resources to operate the parish. Families receiving the school subsidy benefit must complete a Stewardship pledge card *each year* during the Annual Parish Stewardship Campaign. This identifies the financial commitment each household will make to the parish in the Sunday collection. Each family should prayerfully consider the amount of treasure they can pledge to Parish Stewardship, keeping in mind that tuition is not considered a part of tithing. Each family must promise to honor their pledge to the best of their ability. Failure to turn in a card by December 31<sup>st</sup> will result in current year payments being suspended in January, the family being responsible for the remainder of the tuition due.

Catholic education is a tremendous gift, not only for your student/s, but also for the St. John parish community and the greater community at large. As evidence of our support of Catholic education, St. John the Evangelist provides an annual per student subsidy for the youth of our parish that attend either Our Lady of Lourdes or St. Joseph Parish Schools.

In order to receive the parish subsidy, registered parish families must meet with me annually and complete a Statement of Active Parishioner which outlines required criteria in terms of Spiritual and Stewardship commitments. This meeting must be scheduled and the form completed **no later March 15, 2022.**
